SUBJECT: 2017 Market Rent, Cost and Revenue Indices for Housing Providers

Background

On an annual basis, the Ministry of Municipal Affairs & Housing provides indices for costs and revenues to calculate subsidies under the *Housing Services Act, 2011*.

Market Rent Indices

The Ministry has released the **2017** market rent indices, as shown on Appendix A. The market rent index is calculated as the lesser of the rent control guideline and the change in local average rents, by zone within NRH's service area.

Housing providers should use the market rent index to develop their operating budget for **2017**.

Cost and Revenue Indices

Two Index Tables are shown on the attached Appendix B – one for 100% RGI non-profit providers and one for non-profit providers with mixed units (RGI and market) in their portfolio.

The numbers provided in Appendices A & B are percentages. To apply these indices in the subsidy calculation process, convert the number into an index factor by expressing the index as a decimal figure and adding 1.0. For example, 2.1% converts to a factor of 1.021.

Service Manager's Role

NRH will calculate housing providers' **2017** operating budget using the **2017** indices for both 100% RGI Non-Profit projects and Mixed (RGI & Market) Non-Profit projects.

Housing Provider's Role

Housing providers are required to develop their **2017** operating budget in accordance with the **2017** indices as attached.

Housing providers are also reminded that the following information is required to be forwarded to NRH 90 days prior to the start of their fiscal year:

- Market rents/housing charges for fiscal **2017**
- Estimated total RGI revenue
- Estimated property taxes (include copy of final 2016 tax bill)
- Estimated mortgage payments
